Rules/Guidelines:

1. Clothing entries may have been worn but must be clean and pressed for exhibit at the Fair.
2. Entry tags are to be pinned on upper left-hand corner of the garment.
3. WIRE HANGERS MUST ACCOMPANY ALL EXHIBITS. **NO PLASTIC HANGERS!**
4. Be prepared to discuss with the judge the following information: a) fiber content; b) intended use; c) care instructions; d) cost of item; e) pattern details.
5. This department will be judged face-to-face.
6. Clothing members are encouraged to bring their patterns and guide sheets with them to help answer any questions.
7. All posters should be 14" x 22".
8. All garments/outfits judged must be displayed at the Fair to receive premium.
9. All garments/outfits must have been made within the last year.
10. An outfit is at least two pieces such as a top and bottom that coordinate or a dress.
11. Serging techniques can be used where applicable.
12. Enter consecutive class numbers when completing your entry form.
13. Each garment that you construct must have evidence of different construction skills and be made from a different pattern or fabric. Examples of skills: darts, facings, interfacings, zippers, collars, cuffs, hems, buttons, buttonholes, pleats, topstitching, gathers, understitching, matching plaids, stripes and designs, restyle or recycle, altering patterns or tailoring. For advanced clothing construction members, each single garment exhibited must contain at least 2 different advanced techniques.
14. Clothing Revue garments may be entered in clothing exhibit divisions A-C. Garments need not be re-entered under the Clothing Revue for the Fair. The placing information for the Clothing Revue is recorded immediately after the Clothing Revue in June.
15. Champion and special merit awards will be presented. Ribbons only.
16. SPECIAL AWARD – "HCE MERIT AWARD" Youth Awards for outstanding workmanship ribbon and prize money.

Include a 3" x 5" card with an explanation of how the article is used and include a photo of item on the animal and/or rider. **Examples:** grooming apron, western shirt, Huntseat shirt, riding breeches, driving apron, show jacket, show shirt, show vest, show pants, dickie, tail bag, polo wraps, feed bag tote, saddle blanket covers, fly bonnets, saddle pad, quarter sheet, horse blanket/sheet/cooler, Winter Riding Skirt, Winter Wrap, fly mask, bit warmer, saddle bag, horse pillow, stuffed animal horse, hobby horse, horse quilt saddle cover, hay bale bag.

- All members enrolled in 4-H for FFA clothing construction project or equivalent, Quilting, Wool Spinning, or Cultural Arts project may enter Clothing Revue.
- Entries will be judged on 1) sustainability of garment for individual as to color and design; 2) accessorizing of garment; 3) general appearance, neatness, posture, and fit; 4) construction to the extent that it affects general appearance (Judges have the choice of inspecting clothing construction); 5) and/or creativity when appropriate for garment.
- No member can model more than 2 garments in Divisions E or F. A third garment can be modeled by someone else in Divisions E or F. Members may model up to 3 garments in Division G.
- Each member is encouraged to bring patterns, guide sheets, or instruction sheets to answer questions during the Clothing Revue judging.
- A Teen Choice Award will be presented at the Fair to two participants (beginning and advanced) receiving the highest votes from peers to the best outfit.
- A Judge's Choice Award will be presented at the Fair to two participants (beginning and advanced) that have made exceptional garments in the eyes of the judge.
- Clothing project members ages 12-19 may enter the Clothing Revue at the Wisconsin State Fair. Consult the website www.wisstatefair.com/youthexpo for online entry forms and more information.

Division F – Clothing Revue Clothing Construction: 13-19 years old (Fashion Forward and Refine Design or Equivalent)

Class No:

1. Garment for self.
2. Complete outfit for self.
3. Simple garment for another person.
4. Total outfit with accessories purchased from a thrift shop. Outfit must be accompanied by the receipt (s) from the purchase of the items.

Division G – Clothing Revue (open to any member in Clothing, Quilting, or Cultural Arts Projects)

Class No:

1. Embroidered Garment (hand or machine embroidery).
2. Embellished Garment (beads, shell, trinkets, ribbons, fringe, grommets, etc.).
3. Art Garment (painted, stamped, stenciled, tie-dyed, etc.).
4. Restructured Garment. A new garment remolded from an old garment - member must bring a photo of the old garment.
5. Quilted Garment. Garment may combine quilting and other techniques such as knitting/crocheting/sewing and include vests, sweaters, jackets, bottoms, etc.
6. Garment Made from Vintage Fabric or Vintage Embellishments. Not vintage look fabrics. Garment must be made from vintage fabric such as old table cloths, handkerchiefs, lace, bark cloth, old gingham, etc. or vintage embellishments such as lace, beading, etc.
7. Costumes.
